## **ONLINE PRIVACY POLICY AGREEMENT**

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online account and services, and what we will and will not do with the information we collect.

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; and the type of agreement we may have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

**Use of Information Collected.** The Pirates of Port Royal Charters, LLC does not sell, rent or lease any of its customer lists and/or names to any other third parties. The Pirates of Port Royal Charters, LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the products and services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible
